NON-RESIDENT SCHOOL OF CHOICE PROGRAM
APPLICATION REQUIREMENTS
2017 - 2018

The Bridgeport-Spaulling Community School District has decided to opt-in to the Non-Resident School of Choice Program of the State Aid Act (MCL 388.1705). Following are detailed guidelines of the School of Choice Program as defined by Bridgeport-Spaulling Schools.

REQUIREMENTS

All applicants MUST provide a copy of the student's MOST RECENT ATTENDANCE RECORD, DISCIPLINE RECORD AND CURRENT REPORT CARD AT THE TIME THE APPLICATION IS SUBMITTED. For applicants in grades 9 through 12 an up-to-date transcript is REQUIRED at the time the application is submitted. Applications without the required documents will not be considered.

1. ENROLLMENT LIMITS

The Bridgeport-Spaulling School District has openings in the following grades for its Non-Resident School of Choice Program for the 2017 - 2018 school year. The openings are as follows: Kindergarten = 12, 1st = 7, 2nd = 14, 3rd = 11, 4th = 7, 6th = 5, 7th = 5, 8th = 5, 9th = 5, 10th = 5, 11th = 5, 12th = 10.

2. REFUSAL GUIDELINES

Bridgeport-Spaulling Schools may refuse enrollment to any non-resident student who has violated the following rules:

- A student who has been suspended for one to four days in the past academic year may be refused enrollment depending on the issues and conditions for his/her suspension. The student and parent/guardian will be required to have an interview with the principal and/or superintendent prior to final determination of enrollment.
- A student who has been expelled at any time during his/her educational career.
- A student who is determined by the district to not be age appropriate for the program.

3. RANDOM SELECTION

A random draw system will be used as required by law.

4. TRANSPORTATION

The Bridgeport-Spaulling Community School District is not obligated to provide transportation to non-resident pupils or resident pupils enrolled in other districts. Non-resident parents/guardians are responsible for all transportation of their child(ren) to and from Bridgeport-Spaulling Schools.

Attendance & Tardiness: Attendance is very important, as is being at school and ready for class on time. Our attendance and tardy policies are very strict. Violation of the attendance policy will result in the student being excluded from the Bridgeport-Spaulling Community School District. Transportation arrangements should be considered carefully so your child will be at school each day for the entire day.

5. NON-DISCRIMINATION

Non-resident applicants shall not be granted or refused enrollment based on religion, race, color, national origin, sex, height, weight, marital status, or athletic ability, or be in violation of any state or federal law prohibiting discrimination.

6. ENROLLMENT

Applicants receiving approval are informed of the enrollment process at the time of the phone notification.
